

OFFICIAL RULES

The **WGNO “A Charlie Brown Christmas” Quiz Contest** (“Sweepstakes”) starts at 9:00 AM (CT) on Wednesday, November 30, 2016, and ends at 11:59 PM (CT) on Thursday, December 15, 2016 (“Sweepstakes Period”). The sponsor of this Sweepstakes is WGNO-TV, One Galleria Blvd, Suite 850, Metairie, LA 70001 (“Sponsor”). Sequoia Outdoor Supply is the Prize Provider. Sweepstakes shall be subject to these Official Rules, and by entering, all participants agree to be bound by the terms and conditions herein.

1) NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

2) How to Enter:

ENTRY VIA ONLINE: On the WGNO website (www.wgno.com/category/contests), click on the link to the page for the **Charlie Brown Christmas Quiz Contest** to reveal the Sweepstakes registration page. Enter by completing and submitting the online entry form on the WGNO contest page along with selecting answers for the required Five (5) Quiz Questions related to the Charlie Brown Christmas Special (Airs December 1, 2016 at 7 pm on WGNO). The Quiz questions must be answered, however correct answers to the Quiz questions are not required for entry in the contest. **There’s a limit of one entry per person and per email per day during the Sweepstakes Period. Multiple entries from the same person or same email on the same day may be disqualified.** Registration will only be accepted through the form on the WGNO page. All entries must be submitted and received within the Sweepstakes Period. All entries must include registrant’s name, birthday, zip code, email address, gender, and phone number. You must provide all information requested on the entry form, your contact information must be accurate, and you must have a valid e-mail account in order for your entry to be eligible. In the event of a dispute regarding the identity of an entrant, the holder of the e-mail account will be deemed the person who submitted the entry. On-line entries containing attachments, or other information generated by a script, macro or other automated means shall be disqualified.
