**News with a Twist Wizard World Comic Con 2017 Giveaway
Official Sweepstakes Rules**

The **News with a Twist Wizard World Comic Con 2017 Giveaway** ("Sweepstakes") starts at 11:00 PM (CT) on Monday, December 26, 2016, and ends at 3:00 PM (CT) on Monday, January 2, 2017, ("Sweepstakes Period"). The sponsor of this Sweepstakes is WGNO/WNOL-TV, One Galleria Blvd, Suite 850, Metairie, LA 70001 ("Sponsor"). The Sweepstakes shall be subject to these Official Rules, and by entering, all participants agree to be bound by the terms and conditions herein. The prize provider is Wizard World, Inc.

1) NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

2) How to Enter: Enter by watching WNOL edition of the WGNO News with a Twist broadcast at 11 PM on Monday-Friday, December 26-30, 2016, during the Sweepstakes Period. During the broadcast Monday-Friday an announcement with a specific secret keyword of the day will be listed on screen. On the WGNO website (www.wgno.com), click on the link to the contest page for the **News with a Twist Wizard World Comic Con 2017 Giveaway** to reveal the Sweepstakes registration page. Enter by completing and submitting the online entry form on the WGNO contest page along with the specific requested secret keyword as instructed. **Registration will only be accepted through the form on the WGNO page. Entry is allowed once per person and per email address each day during the Sweepstakes Period for a maximum of five (5) entries per person and per email address.** All entries must include registrant's name, age/birthday, email address, phone number and zip code. You must provide all information requested on the entry form, your contact information must be accurate, and you must have a valid e-mail account in order for your entry to be eligible. In the event of a dispute regarding the identity of an entrant, the holder of the e-mail account will be deemed the person who submitted the entry. On-line entries containing attachments, or other information generated by a script, macro or other automated means shall be disqualified. Viewers will be notified and any changes will be posted on WGNO.com.
